Guidance and good practice

Mask wearing and free PPE scheme

As detailed in <u>Provider News 17</u>, guidance was released in December 2022 to give providers more autonomy over universal face mask use. This enables providers to conduct risk assessments to make decisions about the use of face masks across adult social care.

Care workers and visitors to care homes do not routinely need to wear a face mask at all times in care settings, however there are a number of circumstances where it is recommended that care workers and visitors to care settings wear masks to minimise the risk of transmission of COVID-19. These are:

- if the person being cared for is known or suspected to have COVID-19 (recommended Type IIR fluid-repellent surgical mask)
- if the member of staff or visitor is aware that they are a household or overnight contact of someone who has had a positive test result for COVID-19
- if the care setting is in an outbreak see section on outbreak management for further information

If a resident is particularly vulnerable to severe outcomes from COVID-19 (for example, <u>potentially eligible for COVID-19 therapeutics</u>), mask wearing may be considered on an individual basis in accordance with their preferences.

Risk assessments should be undertaken to inform the use of PPE, including face masks and eye protection, when carrying out personal care/cleaning activities and there is a risk of blood or body fluid splashing.

Detailed guidance can be found in the <u>COVID-19 supplement to the IPC resource</u> for adult social care.

The Government has extended the provision of free PPE for all health, social care and public sector workers until their stocks have depleted, or until the end of March 2024 (whichever is sooner). Further details can be found at GOV.UK. Providers are

asked to only order PPE based on current demand, and order limits will continue to be applied and order volumes will be monitored.

Learning disability vaccination clinic details

Please promote the next LLR COVID-19 vaccination clinics for people with a learning disability, who need a first, second or booster vaccination, which are on:

- Tuesday 17 January 2023, 10.15–17.45
- Friday 17 February 2023, 10.15–17.45

The venue is Loughborough Hospital Vaccination Centre, Hospital Way, Loughborough LE11 5JY, and the clinics are open to all ages from 5-years-old to adults.

- Bookings for a child aged 5-11 years old

The clinic is run by specially trained nurses who are very friendly and experienced. Adaptations can be made.

Influenza outbreaks in care homes

Recently, there have been a number of influenza or influenza-like infection outbreaks in care homes.

Across LLR there is a specific pathway for UKHSA to follow once they have been notified by a care home of residents or staff with flu-like symptoms.

In such situations, UKHSA will risk assess whether an outbreak is likely along with the need for swabbing and/or antiviral medication. If these are required, UKHSA will arrange for DHU to attend the care home within 24 hours to assess the residents affected, swab and prescribe antivirals if recommended.

Leicestershire County Council updates

Discharge Fund - enhanced home care solutions

Overview

To assist hospital discharges the Council intends to provide people with enhanced home care packages so that they can be assessed in their own home. This may include 24-hour wrap around care, or an increased number of 'welfare check' calls with the addition of night-time calls.

We also want to enable people being discharged from a mental health bed to have an intensive reablement period - for example, 6 weeks of additional calls to build their confidence in line with their ability prior to the hospital stay. We will shortly be offering training to all Home Care for Leicestershire framework providers regarding mental health support.

These solutions will not suit everyone, and staff discharging patients are being encouraged to think creatively about a support plan that will enable the person to go home, rather than stay in hospital or move to a short-term residential care bed. The key message we are giving to the person in need of support and their family is 'we are using an extended and extensive support package to enable them to go home.'

Criteria

There is no minimum or maximum number of days the increased support can be commissioned for, but the intention is to step the provision down as soon as it is safe to do so.

The requests will be emailed to providers within the same email as the hospital await care list as with other discharges to ensure a speedy response. They will be highlighted to show that they are part of the Discharge Fund plans and to clarify that this will be a short-term arrangement.

The level of support will be reviewed after 7 days to ensure the person's outcomes are being met and the scheme remains appropriate.
