Statement from Director of Public Health, Leicestershire - regarding care home visitor arrangements

On the 22 July 2020, the Government updated its guidance on policies for visiting arrangements in care homes. It states Directors of Public Health and care providers should ensure policies for visiting arrangements and decisions are based on a dynamic risk assessment and minimise risk wherever possible.

This requires consideration of:

- The circumstances of the individual care home (for example, its employee availability, resident demographics and outbreak status)
- Its local circumstances (local epidemiological risk, presence of outbreaks in the wider community)
- The external COVID environment which includes the prevalence and incidence of infection in the local community and/or outbreaks or hotspots which may increase the risk of infection risks from visitors coming into care homes. Leicestershire county does not have high incidence (infection) rates. However, care homes in a lockdown area/intervention area due to higher incidence rates, cannot accept visitors.

If your care home is NOT based in an area with high incidence rates, visiting arrangements should follow the principles below:

- If your care home has an active outbreak, before accepting visitors, the home should be COVID free for 28 days i.e. 28 days since the last suspected or confirmed case of COVID in either staff or residents
- The Care home should have visiting policy in place in line with the guidance above
- Appropriate IPC measures should have been implemented in line with the latest guidance and communicated to relatives/visitors prior to their

attendance at the home. Visiting polices should also include a reminder that relatives with symptoms/positive test result/household member with symptoms should not be visiting

- Scheduling visits so that all residents are not receiving visitors at the same time
- Log kept of all visitors with contact details
- Availability of care staff to escort relatives directly to resident's room and back
- If the location of the care home is in an area of concern due to an increase in rate/rate greater than the national average, then visiting to the care home must stop for the foreseeable future
- Encourage other measures of contact if possible e.g. use of digital communication
- If the number of cases increase in your area, you may be asked to close your care home to visitors under the Health Protection (coronavirus, restrictions) no.3. Regulations 2020.

Access to PPE eportal widens

From 1 September 2020, the Department of Health and Social Care (DHSC) PPE Portal will be expanded to provide PPE to the following sectors, and therefore these service providers will not require access to LRF emergency stock once the Portal roll out is complete.

The following services are currently being contacted and invited to register.

- Adult social care homes and domiciliary care settings (including Supported Living)
- Children's social care including children's residential care and secure care
- Children's residential, special schools
- Primary Care (GP practices, optometrists, dental practices including urgent dental care centres)
- Community pharmacies

The portal stocks:

- Type IIR masks
- Aprons
- Coveralls
- Eye Protection
- Hand Hygiene
- Clinical waste bags
- Gloves
- FFP3 masks

There are weekly order limits, but these limits and the range of PPE stock items are being reviewed to meet all of the Covid-19 PPE needs of the above sectors. Further detail can be found at how to order emergency personal protective equipment.

From 1st September, LPT's Community Health Services SPA will no longer be contactable by fax.

Care providers with NHSmail secure email accounts (or email systems accredited by the NHS) are instead invited to contact the SPA using this secure NHSmail address: lptchs.spa@nhs.net.

Please be aware that you **must not** email patient identifiable information to the SPA from a non-secure email account. This is a data protection breach.

Please contact the SPA using the NHSmail address for your organisation (the socalled generic account), rather than your individual account, to ensure that the answer will be seen even in your absence.

The SPA are also contactable by phone (0300 300 1000). This number must be used in the case of urgent referrals between 21:30 and 07:30 as email referrals will not be processed during these hours.

Please submit only one referral per email, ensure that the subject line includes the word 'referral', and request a read receipt. You may attach Word or PDF documents, no photographs please.
