## The future of adult social care

## Adult social care reform update

Leicestershire County Council has developed a report on progress towards market shaping and charging reform for its Adults and Communities Overview and Scrutiny Committee to consider on 5 September. You can read the paper here.

The report provides information on the Fair Cost of Care analysis and next steps relating to the Council's Market Sustainability Plan.

If you represent a home care provider and have been asked to submit further information towards the home care FCOC exercise, we would be grateful if you could supply the additional detail requested by the deadline which you have been given, to ensure that your data can be used to inform the understanding of a fair cost of care in Leicestershire.

## Framework for Integrated Personalised Care

You should already be aware of the work underway across LLR on the Framework for Integrated Personalised Care, which is replacing the Health and Social Care Protocol (2014).

#### **Guidance and good practice**

#### Preparing for autumn COVID-19 boosters

Older people and those with certain underlying health conditions are more likely to contract COVID-19. This winter it is expected that many respiratory infections, including COVID-19 and flu may be circulating at high levels – this may put increasing pressure on hospitals, care homes and other health care services.

For these reasons, people aged 50 years and over, those in care homes, and those aged five years and over in clinical risk groups are being offered an autumn booster of COVID-19 vaccine. A booster will be offered to front-line health and social care staff, those who care for vulnerable individuals and families of individuals with weakened immune systems. The booster vaccine is also being offered to those at high risk of the complications of COVID-19 infection, who may have not been boosted for a few months. The booster should be taken three months after the last dose. Those eligible for a flu vaccine may be able to have them in the same occasion, and the two vaccines are safe to take at the same time.

The care home vaccination programme will begin on Monday 5 September 2022 and care home managers should ensure all the relevant consents have been collected in good time – please see <u>Provider News 6</u> for more information on obtaining and evidencing consent. It is led by GP practices, and care homes will be contacted with specific details. Staff will be eligible to be vaccinated at the same time as residents within a care home.

Outside of the care home vaccination programme, appointments will be offered between September and December, with those at highest risk being called in first. Appointments will be available from the National Booking Service shortly.

#### Pause in COVID-19 testing

As COVID-19 cases continue to decline both locally and nationally, and with the success of the vaccination programme, routine asymptomatic testing is to be paused from Wednesday 31 August 2022.

This is a move to manage COVID-19 in line with other respiratory illnesses, whilst protecting and treating those most vulnerable to more serious outcomes.

Staff will no longer need to perform twice weekly LFD testing. Professional visitors and visitors providing personal care will also pause testing from this date.

Testing will continue for anyone developing new <u>symptoms</u> of COVID-19, and the <u>current procedures</u> should be followed in this scenario. Testing for residents being newly admitted into the care home from hospital and the community will also continue, as will testing in the event of an outbreak. The table below describes the types of tests to use:

Scenario	Test type
Testing upon admission from the community	PCR*
Testing upon admission from a hospital	NHS will perform PCR within 48 hours prior to discharge
Symptomatic staff member	LFD at home
Symptomatic resident	LFD
Test to release early from isolation	LFD
Rapid response testing	LFD
Outbreak testing	LFD and PCR* as per outbreak testing protocol

\*If somebody has received a positive COVID-19 result (either LFD or PCR) within the past 90 days, they should not perform a PCR test but substitute for an LFD test. In line with the 'Living with COVID' plan, the government will continue to monitor risk and will be ready to resume testing if required. Residents and staff will continue to be protected by appropriate IPC considerations and PPE, as well as protection by vaccination.

Employers in the UK have reported difficulties completing the onboarding process for Ukrainian nationals because references and criminal records checks are currently difficult to obtain within Ukraine.

To aid employers, the Better Hiring Institute has worked with industry and the UK Government to provide guidance which outlines alternative ways to achieve onboarding compliance for people fleeing Ukraine due to the war.

## Personalised care - comfort measures in the last days of life: a free virtual workshop

# National NHS England Learning Disability and Autism Programme: call for feedback

The framework is intended to support the NHS and partners in ICS areas, across regions and nationally, to improve the health outcomes and experiences of people with a learning disability and autistic people.

They have worked with people with lived experience, family carers, representatives from the voluntary and independent sector and teams within NHS England and from ICSs to develop this approach.
